HEREWITH A PRACTICAL GUIDE WHICH WILL EASE THE CIRCUMSTANCES OF YOUR LOVED ONES AND NEXT-OF-KIN IN THE EVENT OF YOUR DEATH

- 1) A letter to your next-of-kin outlining your wishes regarding your funeral, particularly your wishes regarding burial or cremation
- 2) Copy of your will, specifying the location of your original will and providing contact details of your Executor / institution where the will is kept
- 3) A certified copy of your ID
- 4) Certified copies of all your family members, and as far as possible, ID's of the heirs.
- 5) Certified copy of any firearm licences, if applicable
- 6) Original or copy of your marriage certificate
- 7) Original or copy of your marriage contract
- 8) Original or copy of your divorce decree/s
- 9) Original or copy of your children / s birth certificates
- 10) Copies of any rental agreements on properties you own
- 11) Copies of any loan agreements
- 12) Income tax reference number as well as contact details of the person handling your tax affairs
- 13) Original or copy / ies of any title deeds on fixed property registered in your name
- 14) Particulars of any policies and other insurance related products
- 15) Copies of all bank / investment accounts in your name as well as all your credit cards
- 16) Particulars of any funeral policy / ies

- 17) Particulars of any long term Investment Managers and Insurance Brokers, with their contact details
- 18) All vehicle registration documentation for vehicles registered in your name
- 19) Particulars of vehicle and household insurance policies
- 20) Medical aid details
- 21) Death certificate of your predeceased spouse
- 22) A list of contact details of your attorney, executor, trustees, bank manager, doctor, auditor, guardians of your children, employer and best friends etc.
- 23) Ensure that your attorney and executor have details of any foreign beneficiaries



IT IS ESSENTIAL THAT SOMEBODY CLOSE TO THE FAMILY IS AWARE OF THE WHEREABOUTS OF THIS ENVELOPE / FILE AS WELL AS THE ORIGINAL DOCUMENTATION, IN THE EVENT OF THE SIMULTANEOUS DEATH OF THE ENTIRE FAMILY!
